The table below represents the list of Catastrophe Codes related to Extraordinary Loss Events (ELE), as well as other state specific extraordinary workers' compensation loss events, maintained by the WCIO. Check individual jurisdictions for the effective dates of the codes

Catastrophe	Description
Number	Booking
11	Identifies claims resulting from Hurricane Harvey, which made landfall in Texas on
	August 25, 2017. Include claims attributable to this hurricane with an accident date range of 8/23/2017 to 8/23/2020.
12	Identifies claims attributable to COVID-19 Coronavirus with accident dates of 12/1/2019 and subsequent. At this time, the ending accident date has not yet been established. The applicability of the ending accident date may vary by state. Contact your DCO for applicability and specific ending accident dates.
13	Identifies claims attributable to the tornadoes and severe storms that occurred on 12/10/2021 to 12/11/2021 in Arkansas, Illinois, Kentucky, Mississippi, Missouri, and Tennessee. The accident date range for eligible claims is 12/10/2021 to 12/16/2021. The reason for this range is to identify losses sustained on the days of the event and any claims for the rescue, recovery, and cleanup efforts attributed to the event.
14	Identifies claims resulting from the tornado and severe storms that occurred in Moore, OK, and surrounding areas May 18, 2013. Include claims attributable to this tornado and severe storms with an accident date range of May 18 through May 22, 2013.
28	Identifies claims resulting from the explosion and fire at the Imperial Sugar Company sugar refinery in Port Wentworth, GA, which occurred on February 7, 2008. Include claims attributable to this explosion for the accident date range of February 7 through February 8, 2008.
48	Identifies claims resulting from the events of September 11, 2001, to include attacks on the World Trade Center, the Pentagon, and in Pennsylvania. Include claims attributable to the attacks of these events with accident dates of September 11 through September 14, 2001.
77	Identifies claims resulting from the explosion at a ConAgra (Slim Jim) food processing plant in Garner, NC, which occurred on June 9, 2009. Include claims attributable to this explosion for the accident date of June 9, 2009 only.
87	Identifies claims resulting from the rescue, recovery, and clean-up efforts related to September 11, 2001, at the World Trade Center site. Include claims attributable to the efforts that were undertaken between September 11, 2001, and September 12, 2002.
93	Identifies claims resulting from the explosion and fire that occurred at the Kleen Energy Systems plant in Middletown, CT, on February 7, 2010. Include claims attributable to this explosion for the accident date range of February 7 through February 14, 2010.
98	Identifies claims resulting from the explosion and fire that occurred at the West Fertilizer Plant in West, TX, on April 17, 2013. Include claims attributable to this explosion and fire with an accident date range of April 17 through April 19, 2013.
